After graduating from law school in 1996, I began my legal career as a law clerk for the {00128117.DOCX}

Honorable Cynthia A. Baldwin in the Family Division of the Court of Common Pleas. In this role, I conducted extensive legal research on matters involving custody, child support, and spousal support. I also reviewed and modified court orders, responded to appeals, and gained valuable insight into judicial decision-making and case management.

In June of 1998, I joined the Allegheny County District Attorney's Office, where I dedicated 16 years to prosecutorial service. I started in Pre-Trial screening and soon transitioned to the General Trial Unit. In this capacity, I appeared in court daily, prosecuting a wide range of offenses, including driving under the influence, drug possession and delivery, forgery, theft, burglary, robbery, and both aggravated and simple assaults.

In 2001, I was promoted to the Domestic Violence Unit, where I prosecuted cases involving intimate partner violence, including attempted homicide, aggravated assault, simple assault, sexual assault, and Abuse Order violations. I represented victims at Indirect Criminal Contempt hearings, reinforcing my commitment to serving vulnerable populations. In 2007, I briefly served in the Violent Crimes and Firearms Unit, handling cases involving firearms-related offenses.

In 2009, I transitioned to the Child Abuse Unit, taking on the critical responsibility of prosecuting cases involving child physical abuse, sexual abuse, and neglect. I also managed homicide cases, further broadening my legal expertise.

In 2012, I was promoted to Deputy District Attorney, overseeing the General Trial Unit which included approximately 18 attorneys. My responsibilities included supervising attorneys in trial preparation, evaluating plea offers, and ensuring high quality case presentations. I also supervised the Accelerated Rehabilitative Disposition (ARD) program for first-time, non-violent offenders and I managed Miscellaneous Motions Court addressing bail modifications, property seizures, fines, costs, and extraditions.

My leadership extended beyond the courtroom. I participated in the District Attorney's Hiring Committee, contributing to the recruitment and development of new attorneys. In 2013, I was appointed by the Pennsylvania Supreme Court to the Criminal Rules Committee, where I collaborated with judges, defense attorneys, and prosecutors to shape the rules governing criminal practice and procedure statewide.

In 2014, I joined the Pennsylvania Office of Attorney General as Senior Deputy Attorney General, prosecuting cases across 23 counties in Western Pennsylvania. In 2018, I was promoted to Assistant Chief Deputy Attorney General of the Criminal Prosecution Section. In this role, I oversee a team of prosecutors handling serious offenses, including criminal homicide and public corruption cases. I also manage Grand Jury Investigations,

conduct employee evaluations, and play an integral role in hiring decisions.

Beyond my supervisory duties, I lead the Pennsylvania Attorney General's Medical Legal Advisory Board on Child Abuse, a multidisciplinary panel of approximately 50 child abuse experts. The board provides professional consultation to law enforcement, prosecutors, and child protective services, reflecting my ongoing commitment to protecting children and advancing justice.

### COMMONWEALTH V. MICHAEL MCMILLAN CC200706930

Final Disposition of Case:

Michael McMillian was convicted by a jury on April 29, 2008 of First Degree Murder, Aggravated Assault, Possession of Firearm by Minor, and Robbery and was sentenced to life in prison without parole. In 2012, the Supreme Court ruled that juveniles convicted of murder cannot be subject to a mandatory sentence of life imprisonment. Mr. McMillian was resentenced to 30 years to life for First Degree Murder followed by 10 to 20 years for Aggravated Assault, 2 to 5 years for Possession of Firearm by Minor, and 10 to 20 years for Robbery.

### Capsule Summary

Michael McMillan (hereinafter, McMillan") was charged with the death of Will Smoot (hereinafter "Smoot") and also for shooting another individual by the name of James Maurice Jones (hereinafter, "Jones"). On April 17, 2007, McMillan went to the home of Smoot. At the time, Smoot and Jones were gambling while playing the video game Madden. They were in Smoot's bedroom on the 3<sup>rd</sup> floor of the residence. When Smoot's mother, Rachel Larue (hereinafter, "Larue"), arrived home and realized that McMillan was there, she asked McMillan to leave. McMillan walked down the stairs but turned around and went back up the stairs. Moments later, Larue heard gun fire and scuffling. She then saw McMillan running down the stairs and out of the house. Larue ran up to the 3<sup>rd</sup> floor and saw her son laying on the floor suffering from a gunshot wound.

Krystal Hall testified that she saw McMillan running down the street like he was scared. McMillan then came to her residence and asked if he could stay. Ms. Hall testified that McMillan was wearing different clothes than when she saw him running earlier. Ms. Hall asked McMillan why he appeared scared. McMillan responded by stating that he had tried to rob someone and shot Smoot in the head and Jones in the arm.

When the police arrived on scene, they observed a substantial amount of money scattered all over the room, shell casings were about the floor and the furniture in the room was scattered. The police learned that McMillan had been at a residence on McClure Street just after the shooting. The residence was searched and the police found boots with blood stains, blue jeans, cell phones and a hair brush. Forensic DNA testing was performed on some of the evidence and Smoot's DNA was found on the boots and pants belonging to McMillan.

On April 29, 2008, a jury found Michael McMillan guilty of First Degree Murder, Aggravated Assault, Possession of a Firearm by Minor, and Robbery.

McMillan was 17 years of age at the time of the murder and he was homeless. He would spend the night with anyone that would allow him to stay. Although the evidence in the case was strong, I tried to resolve the case through plea negotiations. I recognized the youthfulness {00128117.DOCX}

and hopelessness of McMillan and that a conviction would give him a life sentence. McMillan was unwilling to plead guilty and a jury convicted him of Murder of the First Degree.

### Final Disposition:

Jerry Shoemaker was convicted by a jury for Rape of a Child, Involuntary Deviate Sexual Intercourse with a Child, Aggravated Indecent Assault of Child, Indecent Assault, Endangering Welfare of Children, and Corruption of Minors. He was sentenced to 25 to 50 years for the convictions.

### <u>Capsule Summary</u>:

Jerry Shoemaker (hereinafter "Shoemaker") was the stepfather of 11 year-old MK. One night MK spent the night with her cousin, JL. During the night, MK told JL that Shoemaker was making her perform oral sex and other sexual acts with him. MK begged JL not to tell anyone but JL told her mother. MK was taken to the police and reported the incident. MK described to the police in detail the various sexual encounters that she had with Shoemaker. MK told the police that she had oral sex with Shoemaker the day before her report and she described {00128117.DOCX}

the color of underwear that he was wearing. The police obtained a search warrant and found the underwear in the clothes hamper. The front opening of the underwear was tested for DNA and MK's saliva was present.

This case is significant because I did not want to put an 11 year-old on the stand to testify in front of a room full of strangers. I did not want MK to feel as though she was being revictimized. I attempted to negotiate a plea offer with Shoemaker and his counsel but Shoemaker refused to accept any responsibility. As such, the 11 year-old MK had to face her abuser and questions from his attorney. Unlike most child sexual abuse cases, this case had physical evidence. This evidence along with the credible testimony of MK solidified a conviction.

### Final Disposition of the Case:

Leonard Anthony, Kristopher Garner and Marvin Harpool were charged with the death of Michael Hixson which occurred on September 12, 2003. All three individuals were charged with Criminal Homicide and Conspiracy to commit Criminal Homicide. Leonard Anthony and Kristopher Garner were tried together. Marvin Harpool was a cooperating witness for the Commonwealth and pled guilty to Murder of the Third Degree.

The jury convicted Leonard Anthony and Kristopher Garner. Leonard Anthony was sentenced to 20 to 40 years for Murder of the Third Degree and 5 to 10 years for Conspiracy. Anthony subsequently appealed his case and his conviction was reversed. He then pled guilty to Murder of the Third Degree and Conspiracy. He was sentenced to 13 ½ to 30 years for the convictions.

Kristopher Garner was sentenced to 15 to 30 years for Murder of the Third Degree and 2 ½ to 5 years for Conspiracy.

Marvin Harpool was sentenced to 7 to 15 years for Murder of the Third Degree.

# Capsule Summary

On September 12, 2003, Michal Hixson (hereinafter "Hixson"), while sitting alone in Mellon Park, was stabbed several times and died from his injuries. The police had no suspects at the time of the murder.

Approximately two years after the incident, the police received a tip that one of the men responsible for the murder of Hixson was spotted in downtown Pittsburgh. Marvin Harpool (hereinafter "Harpool") was located and taken to police headquarters where he confessed to his involvement. He also identified the other two individuals that were with him on the night of the murder.

In a jury trial, Harpool testified against his co-conspirators stating that the three men approached Hixson and asked him for his money. Hixson got up to run and he was tripped by {00128117.DOCX}

Kristopher Garner. When Hixon fell to the ground Leonard Anthony began stabbing Hixson. They went through Hixson's pockets and ran in separate directions. Harpool testified that he left Pittsburgh for a few years after the incident. Harpool testified that he was not aware that Leonard Anthony was going to stab Hixson. He thought that they were just going to take his money.

This case is significant because it was the first time that I worked with a cooperating codefendant on a homicide case. Harpool was a key witness to uncovering the identity of the other two suspects. Initially, Harpool only knew the nicknames of the other two suspects. It took approximately two years of working with Harpool, through his attorney, before we uncovered the actual names of the other two suspects. Without Harpool's cooperation, Leonard Anthony and Kristopher Garner may not have been held accountable for their part in this crime.

### Final Disposition of Case:

On May 14, 2007, a jury convicted Frazier Grace of Rape, Involuntary Deviate Sexual Intercourse, Sexual Assault, Kidnapping, Unlawful Restraint, and Simple Assault. Frazier Grace was sentenced to 10 to 20 years for the Rape conviction and 9 ½ to 19 years for the {00128117.DOCX}

Involuntary Deviate Sexual Intercourse conviction.

### Capsule Summary:

Frazier Grace (hereinafter "Grace") was driving and saw his ex-girlfriend Angela Beasley (hereinafter "Beasley") walking down the street. Grace and Beasley had a volatile relationship. At the time of the incident, Beasley had been staying at the Women's Shelter to escape Grace. Grace forced Beasley into his car. When she tried to exit the car Grace punched Beasley in the face and told her he would kill her. He then drove her to his step-father's house in New Castle. New Castle is approximately 45 minutes from the city of Pittsburgh. Grace ordered Beasley to go inside the house. He told her to take her clothes off and get into the bathtub. Beasley kneeled down into the bathtub and Grace began to urinate all over her body. Grace then turned on cold water from the shower and made her stay there. When she was able to get out of the bathtub Grace forced Beasley to have sex with him. They later returned to Pittsburgh and Beasley was able to run away when Grace stopped at Home Depot.

This case is significant because throughout this relationship Grace had assaulted Beasley multiple times. The police had been called for several incidents between the two where Beasley was seriously injured. Beasley never wanted to go forward on any charges against Frazier. However, Beasley's breaking point was when Frazier urinated on her. It was not the physical injuries that she had sustained that cause her to break but it was Frazier humiliating her by making her kneel in a tub while he urinated on her.

### Final Disposition of Case:

Johnnie Barto was charged at five separate criminal informations with sex offenses involving children between the ages of 8 to 12 years old. There were a total of 31 victims. On December 20, 2018, Mr. Barto pled guilty to CC2001800552 and CC 201800584 (the victims where Barto's family members) and he pled *nolo contendere* to the other three criminal informations. On March 18, 2019 Johnnie Barto was sentenced on all five cases with a total sentence of 79 to 158 years of imprisonment. Mr. Barto was also found to be a sexually violent predator.

### Capsule Summary:

Johnnie Barto (hereinafter "Barto") was a family pediatrician in Johnstown, Pennsylvania for many years. He was a well-respected doctor and pillar of the community. In December of 2017, a 12 year-old female patient of Barto reported that he had touched her vaginal areas inappropriately. The 12 year-old victim reported that after her physical examination, she sat on Barto's lap while he was working on the computer. Barto slipped his hand down the pants of the 12 year old and rubbed her vagina. When Barto turned the chair around to face the victim's mother, the victim jumped off his lap immediately. The victim stated that as soon as she got in the car with her mother, she informed her mother of what had just happened. The incident was reported to the police.

Shortly after the first allegation, one of Barto's family members came forward and reported being inappropriately touched by Barto. The Office of Attorney General, under the guidance of Attorney General Josh Shapiro, opened a hotline for anyone that had been sexually assaulted by Barto. Many calls were received and through our investigation, we were able to file additional charges against Barto for assaulting a total of 31 children.

This case is significant because Barto was accused of this same conduct 40 years prior but no one believed the child. In fact, the whole community rallied around Barto and supported him when this was first reported. He became masterful at concealing his actions. Barto would position his body to block the view of the parent. It was reported that he would lean his elbow in the crotch area of the female child while talking to the non-suspecting parent. Barto would also have a child sit on his lap and position the chair so that others in the room could not see {00128117.DOCX}

what he is doing. Additionally, he would have his patients disrobe even if they were there for an ear infection under the disguise that he gives a full examination for all his patients.

Our investigation uncovered sexual assaults that could not be charged because the offense was beyond the statute of limitations. A tremendous amount of work went into locating and interviewing potential victims.
